# **SUSTAINABILITY POLICY**

THIS DOCUMENT SETS OUT THE PROPOSED POLICY AND APPROACH OF FALMOUTH EXETER PLUS IN ADDRESSING THE OPPORTUNITIES & CHALLENGES FOR ACHIEVING SUSTAINABILITY OUTCOMES ACROSS ALL OPERATIONS. THIS POLICY SUPPORTS THE CENTRALISED FX PLUS 2030 ENVIRONMENT & CLIMATE EMERGENCY RESPONSE & DELIVERY PLAN DOCUMENT WHICH OUTLINES:

#### 1. Scope

This policy and all the approach angles involved are applicable to all staff employed at Falmouth Exeter Plus. Through specific approach angles (see 2. Purpose), the policy will additionally be indirectly applicable to staff employed by Falmouth University, the Students' Union, and the University of Exeter. The scope of this policy encompasses all areas of work, from governance to day-to-day operations, encapsulated within the below key work streams and working groups:

- Communications & Behaviour Change
- Catering, Hospitality, Retail, Events & Cornwall Plus
- Energy & Utilities
- Procurement
- Sustainable Travel

# 2. Purpose

Ultimately, the purpose of this Policy is to commit Falmouth Exeter Plus in operating as a more

responsible higher education & delivery service that addresses the challenges of sustainable development. Additionally, one that seeks to create a culture within the organisation that supports and encourages staff and students to recognise that we all have an element of personal responsibility for the environment and to act on that whilst they study and work at Falmouth Exeter Plus.

The Vision of FXPlus' Sustainability Policy is to decarbonise our Scope 1, 2, and 3 emissions for its Cornwall Campuses to net zero, whilst integrating sustainable regenerative and circular principals across all Key Pillars.

More specifically, through this Policy Falmouth Exeter Plus aims to:

- Comply with all relevant environmental legislation and regulations as well as other requirements to which they subscribe
- Set, communicate and implement clear objectives and targets to ensure continued improvement in environmental performance
- Put in place appropriate controls to prevent pollution
- Communicate the policy to all staff and students and make it available to all stakeholders on our website
- Co-operate, where possible, with others in order to develop, utilise and share best practice in terms of environmental performance at a local, regional, HE sector wide and international level

## 3. Definitions

**Sustainable Development** – "development that meets the needs of the present without compromising the ability of future generations to meet their own needs" (Brundtland Report, 1987).

**Operational Stewardship** - We are committed to sustainable development and operating practices through the responsible management of building design, construction, and renovation, landscape practices, energy use, water and waste management, emissions, transportation, and procurement, within a framework of regulatory compliance and fiscal prudence

# 4. Sustainability in our 2030 Strategy

- 4.1 As an anchor institution in Cornwall we recognise our responsibility for the environment, and the impact of our activities and interactions with the wider community.
- 4.2 We will seek out, utilise and share environmental and sustainable best practice and look to drive transformational change wherever we can across the institution.
- 4.3 At a time when student expectations and competition are demanding increased capital investment, we will ensure that our resources are utilised to maximum effect so that we deliver the best value for both institutions and their students.

## 5. Our Approach

- 5.1 In June 2019, Falmouth University joined the University of Exeter in declaring a climate emergency. Falmouth Exeter Plus recognises the threat that climate change poses to the environment and communities, both locally and globally. We must act now to galvanise our efforts, in collaboration with staff, students and partners, by using our resources and knowledge for the protection and benefit of our planet.
- 5.2 Through bold leadership and, in alignment with Government and industry, we will put environmental issues at the forefront of our operations. We recognise the role we can play in driving policy, changing behaviours and providing new ideas and solutions to difficult global problems.
- 5.3 Our 2030 Strategy commits us to a sustainable future, underpinned by the eight working groups which cover all the operational aspects of Falmouth Exeter Plus. Through the development of these working groups climate awareness and environmental responsibility will be embedded in every element of our work, from our campus operations to our strategic planning.
- 5.4 We will seek to create a culture on campus that supports and encourages staff and students to recognise that we all have an element of personal responsibility for the environment and to act on that whilst they are at Falmouth Exeter Plus. We will actively engage with the wider community in order to inspire and catalyse efforts to reduce our adverse environmental impact.
- 5.5 Falmouth Exeter Plus will strive to integrate and balance economic, social and environmental responsibilities within all its activities. We are committed to operating as a responsible institution, addressing the challenges of sustainable development.
- 5.6 Fundamental to our operation is the commitment to continually improve, and to meet (or exceed) environmental legislative and regulatory requirements as they relate to all of our activities.
- 5.7 At the end of each academic year, we will review how we have performed against the sustainability strategy using a quantitative and qualitative performance measurement approach. A report will be circulated to all Cornwall Campus Environment & Climate Emergency Board (CCECEB) members for review
- 5.8 Through this Policy, which applies to the Falmouth and Penryn campuses, Falmouth Exeter Plus aims to:
  - Comply with all relevant environmental legislation and regulations as well as other requirements to which they subscribe
  - Set, communicate and implement clear objectives and targets to ensure continued improvement in environmental performance
  - Put in place appropriate controls to prevent pollution
  - Communicate the policy to all staff and students and make it available to all stakeholders on our website, and
  - To co-operate, where possible, with others in order to develop, utilise and share best practice in terms of environmental performance at a local, regional, HE sector wide and international level

## 6. Sustainability Working Groups

This theme will comprise multidisciplinary input including our on-campus partners at the University of Exeter, Falmouth Exeter Plus and The Students' Union. It will also include wider engagement with Cornwall Council and within specific areas of operational practise, as detailed in the table below.

## 7 People and Behaviour Change

This theme will focus on initiatives to drive positive organisational culture change and influence behaviours. This will include working with Falmouth Exeter Plus staff, Falmouth University, University of Exeter and the Students' Union.

Behaviour change will be supported through, but not limited to, the following methods:

- Top down leadership to drive institutional change promoting staff engagement
- Staff induction to include a sustainability module
- Open Innovation Groups will provide a forum for staff to discuss, innovate and put into action sustainable change
- Sustainable Champions scheme to support embedding sustainable initiatives including processes and behaviour change
- Create a reward scheme for sustainable champions and for individual / group achievement
- Clear, concise and regular communication providing recognition of our achievements

# 8 Overall Governance & Structure

- 8.1 The Penryn Campus has been developed as a joint venture between the University of Exeter and Falmouth University and is managed on behalf of both institutions by their wholly owned service provider, Falmouth Exeter Plus. Falmouth Exeter Plus also provides carbon management, procurement and certain other estates and facilities management related services at the Falmouth campus.
- 8.2 Through our Board of Governors we will ensure that an appropriate structure of responsibility and reporting of performance against plans and targets is established and maintained. This will be reflected in our organisational, management and committee structures as well as in plans, policies and procedures as appropriate.
- 8.3 This policy and progress against it will be reviewed regularly by the Cornwall Campuses Environment & Climate Emergency Board and reported to the Exeter and Falmouth Climate Environment & Climate Emergency Boards. Executive responsibility for the various aspects of Falmouth Exeter Plus's Sustainability Policy rests with individual members of CCE&CEB? This policy is then managed and implemented through normal line management processes as well as through the FX Plus Board, in particular the CEO of FX Plus, and the FX Plus Strategic Sustainability Group (SSG). Representatives from both universities sit on the FX Plus Board and SSG.
